RIERSON CEMETERY

One of our members recently noted that there was a small family cemetery on the south side of Bunker Avenue, and was curious that it now had the appearance of a vacant lot.

With prompting from Society member and trustee Ellen B. Cook, we found that the *Wantagh American Revolution Bicentennial Committee* had published a leaflet on Cemeteries of Old Wantagh as part of the 1976 celebrations. It listed eight local burial grounds:

Quaker Church graveyard, Jackson Family graveyard, Rierson-Seymour Family burial grounds, A Negro burial ground on Oakfield Avenue, A Negro burial ground on Old Mill Road, Birdsall Family burial grounds on North Wantagh Ave, Jones Family burial grounds on Duck Pond Road, Baldwin Family burial grounds on Sunrise Highway.

An article in the September 1973 Information Window by then Historian Ellen Cook identified our Bunker Avenue cemetery as that of the Rierson-Seymour Family. Although there are no headstones remaining, there are burials of Cornelius Rierson and his wife, Catharine (Van Cott) Rierson, their son, John Cornelius Rierson with his wife, and other descendants of Cornelius Rierson.

The cemetery deed, dated March 1, 1869, describes the cemetery easement for the benefit of the heirs of Cornelius Rierson

Cornelius Rierson, (bapt. 1752) was the son of George Ryerson, who resided in what is now Valley Stream. During the American Revolution, George was a Patriot and served in the Militia of Queens County, but his son Cornelius served in a British Loyalist Regiment on Long Island. After the change from British to American rule at the end of the war, Cornelius went to Digby, Nova Scotia with the Loyalist refugees. He eventually returned to Long Island, where his family owned a number of farms in Hempstead Town, and settled on Long Island. His son, John (1793 - 1829) lived on one of the family farms in what is now Wantagh. When the area became more developed, the family cemetery was dignified with an official deed.
